

GA DFCS Child Maltreatment Reports: All Calls, CY2019 to CY2021






GA: Calls from Education & Child Care Sources

- Press inquiries focused on education report sources (teachers, day care, etc.)
- Overall calls dropped ~49%; Education source calls dropped ~90%.
- That's typical for June-July, and Spring Break, but NOT March-May.
- The drop at the end of August 2021 is likely reporting lag, but what about the early January & April 2021 drops?


GA DFCS Child Maltreatment Reports: Calls from Education & Child Care Sources, CY2019 to CY2021






GA: Puzzling 2021 Drop in Physical & Sexual Abuse Calls?

GA DFCS Weekly Calls to Intake: Criminal & Sexual Allegations, CY2019 to CY2021






GA: Removals to Foster Care

GA DFCS Weekly Removals to Foster Care






GA: Reunifications

GA DFCS Weekly Reunification Discharges






GA: Finalized (date of last parent) TPRs






GA: Adoptions

GA DFCS Weekly Adoption Discharges






GA: Guardianships






Atlanta AVLF SWON: CPS ~ Evictions?

- Atlanta Volunteer Lawyers Foundation (AVLF) <u>embeds lawyers</u> in 6 Atlanta Elementary Schools for a project called <u>Standing with Our Neighbors</u> (SWON).
- They try to <u>improve school stability by</u> <u>preventing evictions</u>. (aka decreasing school "Mobility")
- Casey Family Programs wants to find out if SWON improves any CPS outcomes (reports, removals, days under investigation, days in family support).
- Chart:
 - Blue are Evictions
 - Red are CPS Reports
 - Circles are SWON

 Triangles are Others
