






SUBSTANTIATED CASES PER 10K CHILDREN IN COUNTY June 2021 – May 2022




AVERAGE MONTHLY REMOVALS PER 10K CHILDREN IN COUNTY


County Rankings: Average Removals per 10,000 Children in the Population per Month, April 2021 through March 2022



AVERAGE MONTHLY REMOVALS PER 10K CHILDREN IN COUNTY




PERCENTAGE OF SUBSTANTIATED VICTIMS REMOVED TO FOSTER CARE June 2021 – May 2022



PERCENT DISCHARGED WITHIN 1 MONTH OF REMOVAL April 2021 – February 2022


County Rankings: Percentage Discharged within 1 Month of Removal Among Children Removed During Latest 11 Months










AVERAGE DAILY CHILDREN IN CARE PER 10K CHILDREN IN COUNTY

County Rankings: Average Daily Children In Care per 10,000 in the Population During April 2021 through March 2022




PLACEMENT TYPES BY PERCENT March 31, 2022



12 MONTH PERMANENCY


April 2020 – March 2021 removal

County Rankings: Permanence within 12 months of April 2020 through March 2021 Removal




PERCENT OF CHILDREN IN CARE OVER 18 MONTHS March 31, 2022

County Rankings: Percent of Children In Care Over 18 Months on March 31 2022




PERCENT OF CHILDREN WITH APPLA PLANS March 31, 2022

County Rankings: Long Term Foster Care Plan Goal Children In Care on March 31 2022




PERCENT DISCHARGED TO EMANCIPATION April 2021 – March 2022





August 2021 – July 2022





April 2021 – March 2022




MEDIAN LENGTH OF STAY AMONG ALL CHILDREN DISCHARGED IN LATEST 12 MONTHS

County Rankings: Median Length of Stay in Foster Care Among All Children Discharged During Latest 12 Months




MEDIAN LENGTH OF STAY AMONG CHILDREN REUNIFIED IN LATEST 12 MONTHS

County Rankings: Median Length of Stay in Foster Care Among Children Discharged for Reunification During Latest 12 Months




MEDIAN LENGTH OF STAY AMONG CHILDREN DC'ED TO GUARDIANSHIP IN LATEST 12 MONTHS
